The publication and implementation of this guide are carried out in accordance with Article 45/f, as amended by Law No. 6287, and the “Regulations on the Admission of International Students” determined by the Council of Higher Education (YÖK). Applicants are deemed to have accepted the regulations stated in this guide and the relevant legislation. Announcements and information regarding the application and admission processes are published on the website of the Ankara Yıldırım Beyazıt University (AYBU) Directorate of Student Affairs, and these announcements are considered official notifications to the applicants.

The application fee specified in the guide is determined by the AYBU Executive Board and announced to the public via AYBU’s official website. Application centers, banks, intermediary institutions, etc., cannot charge candidates any fees other than those specified in the guide and on AYBU’s website. AYBU accepts applications for international student admissions solely online through its website, without intermediaries, and only upon payment of the application fee stated in the guide. Fees paid by candidates who do not apply or make a preference, whose applications or preferences are deemed invalid, who pay for a non-fee-required process, or who make multiple payments for the same process, will not be refunded or transferred. It is the applicant’s responsibility to ensure the correct payment of fees. Applicants may send their petitions regarding AYBU's 2026–2027 academic year international student applications and results to the address specified below.

## INTERNATIONAL STUDENT ADMISSION

Applications and admissions of international students to Ankara Yıldırım Beyazıt University (AYBU) associate and undergraduate degree programs for the 2026–2027 academic year are carried out in accordance with the “Regulations on the Admission of International Students” prepared by the Council of Higher Education under Article 45/f of Law No. 2547.

## APPLICATION

### WHO CAN APPLY?

Provided that they are in their final year of high school or have already graduated;

1. Foreign nationals, provided that they have not studied at or graduated from secondary education (high school) institutions in Türkiye [except for foreign nationals who have completed their entire high school education at embassy schools or international private educational institutions listed in the MOBİS system, as well as foreign nationals who came to Türkiye with in the scope of projects conducted by the Ministry of National Education or the Council of Higher Education]
2. Those who were Turkish citizens by birth\* and later lost Turkish citizenship by obtaining permission for renunciation from the Ministry of Interior, as well as those who can document that they hold a Blue Card granted upon request to individuals who lost Turkish citizenship (provided that they have not studied at or graduated from secondary education (high school) institutions in Türkiye or the TRNC).  
*\*Article 7 of the Turkish Citizenship Law No. 5901 states: “(1) A child born within or outside Türkiye to a Turkish citizen mother or father within the union of marriage is a Turkish citizen.” Therefore, it is recommended that candidates applying for international student admission quotas review the Turkish Citizenship Law.*
3. Those who were originally foreign nationals but later acquired Turkish citizenship, and those with dual citizenship in this situation (provided that they have not studied at or graduated from secondary education (high school) institutions in Türkiye or the TRNC).
4. Those who are Turkish citizens and have completed all of their secondary education (high school) in a foreign country other than the TRNC, including those who completed all of their secondary education (high school) in Turkish schools opened under the supervision of the Ministry of National Education (MEB) in a foreign country outside the TRNC.
5. Those who are citizens of the TRNC (provided that they have not studied at or graduated from high schools in Türkiye or from high schools in the TRNC that follow the Turkish curriculum), and who possess GCE A Level qualifications, TR-YÖS, or meet the criteria specified in the application and admission guidelines of higher education institutions approved by the Council of Higher Education (YÖK).

Applications to appropriate category of 2026-2027 academic year associate and undergraduate degree programs of AYBU, announced in this guide will be accepted.

### WHO CANNOT APPLY?

1. Turkish citizens who have completed their entire secondary education (high school) in Türkiye or TRNC,
2. TRNC citizens or dual nationals of whom one nationality is TRNC, who have studied at or graduated from high schools in Türkiye or from high schools in the TRNC that follow the Turkish curriculum.
3. Dual nationals whose first nationality by birth is Turkish citizenship, as defined in Article 7 of the Turkish Citizenship Law No. 5901 (except for those who meet the conditions specified in item 4 of the applicants).

*At AYBU, the ECTS credits for courses are determined based on the necessary workload in accordance with the students' learning outcomes. With tools such as the Diploma Supplement and ECTS credits, facilitating the recognition of the education received by students abroad, thereby increasing professional and academic mobility is aimed.*

4. Turkish citizens, or dual nationals whose first nationality by birth is Turkish citizenship as defined in Article 7 of the Turkish Citizenship Law No. 5901, who have received their education in schools operating under embassies in Türkiye or in foreign high schools located in Türkiye.
5. a) Applications from TRNC citizens, individuals who have renounced Turkish citizenship and those holding a Blue Card, who have studied at or graduated from secondary education (high school) institutions in Türkiye or the TRNC,

b) Applications from foreign nationals who have studied at or graduated from secondary education (high school) institutions in Türkiye (except for foreign nationals who have completed their entire high school education at embassy schools or international private educational institutions listed in the MOBİS system, as well as foreign nationals who came to Türkiye within the scope of projects conducted by the Ministry of National Education or the Council of Higher Education), **are not accepted**.

**ATTENTION!** As of 2026, the Council of Higher Education (YÖK) has decided that TRNC citizens, individuals who have renounced Turkish citizenship and those holding a Blue Card, as well as foreign nationals (except for those studying in embassy schools, international private educational institutions registered in the MOBİS system, and foreign nationals brought to Türkiye within the scope of projects conducted by the Ministry of National Education) **who enroll in and/or graduate from secondary education institutions in Türkiye, will only be able to gain admission to higher education institutions in Türkiye and the TRNC through the Higher Education Institutions Examination (YKS)**. Therefore, these candidates will be placed based on their **YKS results**.

## APPLICATION TYPES AND QUOTAS

Candidates who meet the application requirements can apply for the AYBU international student quota announced in this guide in the categories listed below. If they are entitled to enroll, candidates pay the tuition fee determined for the quota type they have applied for. Please refer to Table 1 at the end of this guide for the quotas and tuition fees of AYBU's associate and undergraduate programs for the 2026-2027 academic year.

**Foreign Nationals Quota:** This is the type of quota to which single citizens of other countries or foreign nationals who later became Turkish citizens can apply.

**YTB High Schools Quota:** It is the type of quota that graduates of high schools announced by the Presidency for Turks Abroad and Related Communities will apply. Candidates with Turkish citizenship who will apply in this category must upload documents confirming their entry to/ exit from Türkiye into the system at the application stage. Candidates who graduated from the relevant high schools and do not apply under this quota type (ID type) **cannot benefit from the fee exemption**.

**Quota for Blue Card Holders/ Turkish Citizens Who Have Completed Their High School Education Abroad:**

- ❖ This category of quota is intended for individuals who were Turkish citizens by birth but later renounced Turkish citizenship by obtaining permission to do so under Article 28 of the Turkish Citizenship Law No. 5901, and who hold a “Blue Card” issued by the General Directorate of Population and Citizenship Affairs of the Ministry of Interior of the Republic of Türkiye.
- ❖ It also applies to Turkish citizens or dual nationals whose first nationality is Turkish citizenship, who completed their high school education abroad (provided that they meet the conditions specified in item “4” above regarding eligible applicants). Applicants of this quota type are required to submit their documents showing their entry to/ exit from Türkiye to the system.

**TRNC Quota:** In accordance with the decision of our University Senate dated 06/07/2023 and numbered 2023/13/15, and within the framework of the protocol signed on 13/07/2023 between our Rectorate and the Ministry of National Education of the TRNC, this is the quota type to which TRNC citizens (who meet the conditions specified in item “5” above regarding eligible applicants) may apply.

## DOCUMENTS REQUIRED FOR APPLICATION\*

While applying online, candidates must upload **scanned copies** of the documents listed below completely and accurately. These documents may be in **Turkish or English. Applicants whose documents are in a language other than Turkish must submit Turkish or English translations of these documents.** Applications and/or placement procedures of candidates with missing documents, incorrect documents, incorrect quota types or who have more than two program preferences will be deemed invalid, even if they are entitled to register, and their enrollment will not be completed.

1. Pages of the passport showing identity information and photograph (For applicants who select the “I do not have a passport” option, documents such as Turkish ID card, Temporary Protection Identification Card, national identity card, etc. may be uploaded.)
2. High school diploma (Applicants without a diploma may submit a Provisional Graduation Certificate.),
3. For those whose high school diploma does not include a graduation GPA, an official high school transcript approved by the school administration (Transcript, Kepingname etc.),
4. For applicants applying with one of the exams listed in Table 2 of the guide, a valid result certificate showing that the minimum required score has been obtained.
5. Documents required to verify the application type, as applicable:
  - ❖ Identity document related to the applicant’s nationality
  - ❖ For dual nationals, one of whose nationalities is Turkish, a document proving that Turkish citizenship is not their primary nationality (a full population registration sample must be uploaded to the system by the final application date)
  - ❖ For those who were Turkish citizens by birth but lost Turkish citizenship by obtaining permission to renounce citizenship, a certificate of renunciation of Turkish citizenship (for those without a Blue Card),
6. Bank receipt showing that the application fee has been paid in the applicant’s **own name.**
7. For Blue Card holders or Turkish citizens who completed their high school education in a country other than the TRNC, a document showing entry and exit records to Türkiye (can be obtained via e-Devlet at [turkiye.gov.tr](http://turkiye.gov.tr)).
8. For foreign nationals who completed their entire high school education in embassy schools / international private education institutions listed in the MOBİS system, or those brought to Türkiye within projects conducted by the Ministry of National Education or the Council of Higher Education, an official confirmation letter from the relevant Provincial Directorate of National Education verifying this status.
9. If available, a language proficiency certificate for the language of instruction of the program applied to.

## IMPORTANT NOTES

\*Applicants must meet the relevant requirements for the quota type to which they apply. Candidates whose nationality includes Turkish citizenship are required to declare this information during the application process. Applicants who hold Turkish citizenship but fail to declare it at the time of application will not be registered. Candidates with dual citizenship are also required to declare both nationalities during the application process.

\*Candidates whose applications have been preliminarily reviewed and approved by the Directorate of Student Affairs (ÖİDB) cannot update their passport and/or identity information; their procedures will continue based on the information and documents they initially declared.

\*Applicants whose high school diploma, provisional graduation certificate, and/or valid exam result or certificate showing minimum required score does not include a numeric equivalent for letter grades must submit an official document showing the numerical equivalents of those letter grades.

## REQUIRED DOCUMENTS FOR UNIVERSITY REGISTRATION



1. Acceptance Letter,
2. Bank receipt showing that the applicant has paid the fall semester tuition fee in their own name,
3. Original and photocopy of the high school diploma (The diploma must include an apostille certification, or an equivalent authentication for countries not party to the Apostille Convention. Documents in languages other than Turkish or English must also include a Turkish translation.)
4. Original and photocopy of the high school transcript (The transcript must include an apostille certification, or an equivalent authentication for countries not party to the Apostille Convention. Documents in languages other than Turkish or English must also include a Turkish translation.)
5. For those whose high school diploma does not indicate a numeric equivalent of the graduation grade, a document showing the numerical equivalent of the letter grades,
6. For foreign nationals who completed their high school education in embassy schools / international private educational institutions listed in the MOBİS system, or those brought to Türkiye within projects conducted by the Ministry of National Education or the Council of Higher Education, an official confirmation letter from the relevant Provincial Directorate of National Education regarding this status,
7. Diploma Equivalency Certificate (Can be obtained from Provincial Directorates of National Education in Türkiye or from Turkish Education Attaché/Consulates abroad; applicants whose applications are still in process may submit their application documents),
8. Original exam result document showing that the minimum required score has been achieved for applicants applying with one of the exams listed in Table 2 of the guide (if applicable).  
[Applicants applying with GCE A Level must submit their final results.]
9. Two (2) biometric photographs sized 4.5 x 6 cm (taken within the last 6 months),
10. Original and photocopy of passport and valid visa page (Visa is not required for diplomatic passport holders or Blue Card holders. Applicants residing in Türkiye must also submit a copy of their residence permit. Copies of pages showing identity information, visa, and entry stamp must be provided.)
11. Population Registration Sample (Dual nationals, one of whose nationalities is Turkish, must submit a population registration sample showing that their first nationality is not Turkish citizenship.)
12. Special identity document held by the applicant (temporary or international protection ID card, Blue Card, document showing date of renunciation of Turkish citizenship, certificate showing renunciation of citizenship for TRNC citizens with dual nationality, etc.)
13. For Turkish citizens who completed their high school education abroad and were admitted under the relevant quota, entry-exit record to Türkiye (can be obtained via e-Devlet at [turkiye.gov.tr](http://turkiye.gov.tr)),
14. Language proficiency certificate for the language of instruction of the applied program (if available),
15. Medical report stating that the applicant does not have any infectious disease, obtained from hospitals in Türkiye,
16. For Coaching Education and Sports Management programs, a medical report from fully equipped hospitals in Türkiye confirming that the applicant's health condition is suitable for studying in the relevant program,
17. For Civil Aviation and Cabin Services programs, a medical report confirming fitness for flight, obtained from the healthcare institutions listed in the link below:

18. Power of attorney (if applicable)  
(The power of attorney must include apostille certification or an equivalent authentication for countries not party to the Apostille Convention. Documents in languages other than Turkish or English must also include a Turkish translation.)
19. International Student Enrollment Contract.

## APPLICATION FEE

Candidates must pay the application fee within the application period using the information (identity/passport number) written on their passport or identity card appropriate to their application type. Candidates who choose to pay the fee at the bank must inform the bank officer that they are depositing the application fee and provide the identity or passport number used in the application. On the bank receipt, the following information must be correctly stated: identity number or passport number, name and surname, and application name: AYBÜ 2026-2027 Academic Year International Student Application. Candidates must keep the bank receipt and upload it to the Online Application System. Candidates applying from within Türkiye can also pay the application fee via internet banking without going to a bank branch. The application fee payment process will end on June 26, 2026, at the end of business hours (5:00 PM Turkey time). It will be helpful for candidates making international payments to consider that bank transfers may take a long time to process.

## HOW TO APPLY?

The procedures that candidates who wish to apply for the international student quota for the 2026-2027 academic year at AYBU's associate and undergraduate programs must follow are listed below:

1. The "2026-2027 Academic Year International Student Application Guide" published on the website of the AYBÜ Student Affairs Department (<https://aybu.edu.tr/oidb>) should be carefully read.
2. Candidates will be able to access the "Applicant Application Form" through the online system on AYBU's website [https://obs.aybu.edu.tr/oibs/foa\\_app/](https://obs.aybu.edu.tr/oibs/foa_app/) within the application period. Applications will only be accepted through this online system, and candidates can submit their applications individually via the internet. Instructions for filling out the form can be found on the announcement screen.
3. Candidates can select up to two (2) programs based on their exam/diploma type and score. All applications of candidates who are found to have applied to more than two (2) programs using different identity information will be deemed invalid.
4. Candidates only need to submit one exam with the highest score from the valid exams listed in the table, in order of priority, in the "Exams" section of the application form. Other exams entered, apart from the one that will be evaluated in the review stage, will not be considered.
5. Candidates will complete their applications after paying the application fee. Applications of candidates who do not pay the fee within the specified period will be considered incomplete and will be canceled.
6. The documents of applicants whose applications have been recorded are reviewed by the authorized staff of the Student Affairs Department to ensure compliance with the application requirements. If there are no deficiencies and all conditions are met, the applicant's submission is approved in the system. Applications of candidates whose status is changed to "incorrect/incomplete documents" in the system will not be considered for evaluation until they complete the missing documents and re-approve their application.

7. Applicants who do not meet the application requirements or fail to upload the required documents within the application period will have their application status changed to "rejected" in the system, and their applications will not be considered for evaluation.

**ATTENTION!** Applicants are solely responsible for the accuracy and validity of the information provided in their applications, as well as for any errors or omissions that may be detected after the application has been approved. Candidates who are in their final year of high school and apply based on expected results must meet the required grade at the time of enrollment. If the required grade is not met, registration will not be completed even if the candidate has been granted the right to enroll. Applications containing incorrect or inappropriate information or documents will be canceled. Candidates who are granted the right to enroll must present the original versions of the documents they uploaded to the system for verification at the time of registration. The registration of candidates who complete the enrollment process at AYBU will be considered provisional until the final verification of their information and documents is completed.

## ANNOUNCEMENT OF APPLICATION RESULTS

The application results will be announced in the “Announcements” section of the website of the AYBU Directorate of Student Affairs. These announcements will serve as official notifications, and no separate result document will be sent to the applicants. Candidates will be able to access their application results using their application numbers and passwords via the following web address: [https://obs.aybu.edu.tr/oibs/foa\\_app/](https://obs.aybu.edu.tr/oibs/foa_app/). One of the following statuses will be included in the results:

- a) You have not qualified for enrollment.
- b) You have qualified for enrollment.
- c) Pending.

“*Acceptance Letter*” will be sent via the online application system to candidates who are granted the right to final enrollment at AYBU. Since the evaluation for enrollment from the waiting list is based on candidates who are on hold, applicants whose result is announced as “*Pending*” must regularly check the announcements on the website of the AYBU Directorate of Student Affairs and the email addresses they provided in the application system. TRNC citizens will complete their applications within the dates specified in this guide using their expected GCE A-Level exam results. If these candidates submit the document showing their finalized results, announced in August, to the Ministry of National Education of the TRNC, their applications will be evaluated and the placement results will be announced on **17.08.2026**. Candidates who applied to programs that admit students through a Special Talent Exam and passed the preliminary evaluation must succeed in the Special Talent Exam conducted by AYBU in order to gain the right to final enrollment. The “*Acceptance Letter*” sent to these approved applicants is **provisional**, and the final right to enroll will only be granted upon passing the “*Special Talent Exam*” conducted by the relevant academic unit.

Candidates who have gained the right to enroll in our university and are currently enrolled as regular students in a similar program at another higher education institution in our country must have their registration canceled at the other institution at the time they apply for enrollment at our university.



## EVALUATION

### HOW ARE APPLICATIONS EVALUATED?

Applicants who apply for the 2026-2027 academic year for associate and bachelor's degree programs at AYBU under the international student quota will undergo a two-phase process as outlined in the steps below.

#### 1. Preliminary Review of the Application Documents

- a) All applicants are reviewed according to the quota of the "Application Type" they have applied for. Applicants who do not submit the required documents for their application type will have their application status changed to "Incorrect/Incomplete Documents."
- b) The application status of candidates who upload their documents to the system completely will be changed to "Approved."
- c) The application status of candidates whose applications do not meet the above-mentioned requirements will be changed to "Rejected."
- d) After the application status is updated, candidates will receive an email at the address they provided in the form, stating "Your application status has been changed." It is the candidates' responsibility to monitor their application status through the "Online Application System" and pay attention to the relevant notifications in the explanation section.

**ATTENTION!** Due to the potential high volume of applications in the last week of the application period, application evaluation may extend beyond the deadline. To avoid the risk of rejection due to incomplete documents, candidates are advised not to leave their applications until the last days. If there are any doubts regarding the documents uploaded with the application, the Directorate of Student Affairs may request additional information and documents.

#### 2. Evaluation of Applications

Quota distribution for placement in programs is done according to the applicants' country of citizenship. The placement results will be announced on the AYBU Directorate of Student Affairs website. Table 2, which includes the exams to be considered in the evaluation of applications and the minimum scores required for admission, is provided at the end of this guide.

Applicants whose applications are accepted through the Online Application System will be evaluated according to the following steps, considering the scores of the diplomas or exams listed in Table 2, their preferences for higher education programs, and the quotas and requirements based on the country quotas for these programs. Those who are successful in the ranking will be placed in the relevant program according to their preferences.

- a) In the placements for the relevant program, candidates who hold the exam result documents specified in Table 2-A, within the quota distribution according to country of citizenship, will be given priority.
- b) After the placements of these candidates are completed, the remaining quotas will be filled based on the country of citizenship quota distribution, considering Table 2-B.
- c) After these placements are completed, if any vacancies remain, candidates will be placed according to Table 2-C, taking into account the quota distribution based on country of citizenship.
- d) In case of equal diploma/exam scores during the evaluation, priority will be given based on the language proficiency certificate score, if available. To see the language exams recognized as equivalent by our university, please refer to the language equivalency table in the Useful Information section of this guide.
- e) Candidates who have applied to departments or programs that admit students through a special talent exam and meet the preliminary acceptance requirements will be evaluated based on their performance in the special talent exam conducted by the relevant Faculty/Conservatory.

- f) The evaluation of applications and the placement of candidates are entirely under the authority of AYBU. After the registration process at AYBU is completed, if candidates who have been granted the right to enroll in programs do not register, or if there are no applicants for certain programs, additional placements may be made for the vacant quotas. In such cases, AYBU has the discretion to alter the evaluation methods specified in the table.
- g) Meeting the application requirements does not guarantee admission to the program. AYBU is free to fill or leave the quotas unfilled.
- h) The applications of children of foreign diplomats serving in Türkiye will be evaluated under the priority exam/diploma category in Table 2-A, provided they meet the minimum application requirements.

## TUITION FEE

Candidates accepted to our university are responsible for providing the financial means necessary to cover their living expenses in Türkiye during their study period (such as accommodation, meals, books, stationery, personal needs, etc.). Students who are granted the right to enroll are considered to have accepted this responsibility.

Candidates who are granted the right to enroll at our university must pay the first installment of the tuition fee before the registration process. Once the tuition fee is paid, the payment is automatically reflected in the university's registration system. Except for scholarship students, those who do not pay or underpay the tuition fee will not be registered at the university. No refunds will be made to students who voluntarily withdraw after registration.

**ATTENTION!** Students who will study in the preparatory class of AYBU School of Foreign Languages are required to pay the tuition fee of the program they are enrolled in. Students who will receive Turkish preparatory education at AYBU DİLMER must pay the tuition fee of the program they have been placed in during university registration. This fee will be transferred to the first semester of the program they will begin after completing the preparatory education. For the Turkish preparatory education, the course fees are determined by DİLMER must be paid separately.

## USEFUL INFORMATION

### LANGUAGE OF INSTRUCTION

The language proficiency certificates accepted by our university, exemption exams, and opportunities regarding preparatory language courses are listed below. The language of instruction for each program is also specified in the quota table. Applicants are required to provide proof of language proficiency according to the language of instruction of the program they are applying to. Candidates who do not have a valid language certificate must meet the conditions specified below. Applicants who have completed their secondary education in the last three years in an institution where the designated language of instruction is the native language of the country, and which is attended by citizens of that country, will be considered exempt from the language requirement. Students who are required to take preparatory language education must complete it within two years. The maximum period for students required to undertake preparatory education in two different languages is also two years. Students who fail to complete the preparatory program within the two-year period will be dismissed from the program.

#### 1. English Preparatory Program

Candidates who are accepted into programs with partially or fully English as the language of instruction and do not have English language proficiency are required to take the proficiency and placement exams conducted by our University's School of Foreign Languages. To learn the exam dates and obtain detailed information, candidates can contact the University's School of Foreign Languages.

Those who provide documentation of sufficient scores from internationally recognized exams listed below or the Assessment in General English Exam (AGE-YDMS) conducted by our University, for programs with partial or full English as the language of instruction, are entitled to directly begin the relevant program. Results of international exams that are equivalent to the AGE, among those conducted in Türkiye, **will not be considered equivalent** if the sessions are not held in government university buildings and if the exam location and date information is not provided on the result documents.

## 3. Turkish Preparatory Program

For programs where the language of instruction is partially or fully Turkish, candidates must provide proof of their language proficiency. The valid Turkish language proficiency certificates (C1 level) obtained by candidates from AYBU DİLMER, Yunus Emre Institute, or centers offering Turkish language education accepted by YÖK, within the last 2 years, will be accepted. Candidates who possess these certificates are entitled to directly begin the relevant program if they are enrolled.

For programs that provide education entirely in a foreign language, a Turkish Proficiency Certificate is not required at the time of application. However, students must submit a **B1 Turkish Proficiency Certificate** before graduation. Additionally, students who are granted the right to enroll in the Medicine (English) program, must submit a C1 Turkish Proficiency Certificate to their Faculty before registering for courses in the 4th year.

Candidates who do not have Turkish language proficiency, if enrolled, are required to take the proficiency and placement exams conducted by AYBU DİLMER, which are announced on the website <https://aybu.edu.tr/dilmer/>. To learn the exam dates and obtain detailed information, candidates can contact AYBU DİLMER. Candidates who do not know Turkish will receive education in Turkish preparatory courses offered by DİLMER.

### **HEALTH INSURANCE**

International students who have been accepted to AYBU and have entered or will enter our country are required to submit a valid health insurance certificate to our University during their registration, in accordance with the provisions specified in Article 60, paragraph 7 of the Social Insurance and General Health Insurance Law No. 5510.

## IMPORTANT NOTES

- \* The annual tuition fees announced in USD will be converted into Turkish Liras based on the Central Bank's foreign exchange selling rate on the first business day one week prior to the registration date for the students admitted from the main list, and will be paid in two installments. The first installment is paid at the time of university registration; the second installment is paid on the tuition fee payment dates for the spring semester, as announced in the AYBU 2026–2027 Academic Year calendar. In subsequent years, tuition fees will be paid per semester, based on the Central Bank's foreign exchange selling rate on the first business day one week prior to the payment dates indicated in the academic calendar for the fall and spring semesters.
- \* If the amount resulting from the conversion into Turkish Liras is lower than the minimum fees announced in the Presidential Decree published in the Official Gazette for the relevant academic year, the minimum fee specified in the Presidential Decree shall be collected.
- \* Students who exceed the regular duration of study shall pay 30% more than the tuition fee converted into Turkish Liras for the subsequent semesters.
- \* In cases where a tuition fee refund is required, the amount converted into Turkish Liras based on the foreign exchange selling rate shall be taken as the reference, and the refund shall be made in Turkish Lira
- \* According to Article 3, Paragraph 5 of the Presidential Decree titled "Decision on the Determination of Tuition Fees and Contribution Fees to be Collected from Students as Contribution to the Current Service Costs in Higher Education Institutions in the Academic Year," published in the Official Gazette, students who have graduated from high school level overseas educational institutions affiliated with the Ministry of National Education, the Türkiye Diyanet Foundation, or the Türkiye Maarif Foundation; from International Imam Hatip High Schools operating under the International Imam Hatip Student Programs jointly conducted by the Türkiye Diyanet Foundation and the Ministry of National Education; from minority high schools; or from Imam Hatip high schools affiliated with Muslim religious authorities, and who are admitted to associate or undergraduate programs under international student quotas, are subject to the tuition fees specified in Annexes (I) and (II) of the Decision. For such students enrolled in first education programs and continuing within the regular period of study or newly admitted, tuition fees are covered by the budget of the Presidency for Turks Abroad and Related Communities (YTB).

## CONDITIONS AND EXPLANATIONS RELATED TO PROGRAMS

- 1: The medium of instruction for students enrolled in this program is Turkish, and only a Turkish preparatory class is offered. Candidates who wish to apply for this program are required to carefully read the information provided under the heading "Language of Instruction."
- 2: The medium of instruction for students enrolled in this program is **30% English**. Both Turkish and English preparatory classes are available. Candidates who wish to apply for this program are required to carefully read the information provided under the heading "Language of Instruction."
- 3: The medium of instruction for students enrolled in this program is English. A one-year compulsory English Preparatory Program and a one-year compulsory Turkish Preparatory Program are implemented. Candidates who wish to apply for this program are required to carefully read the information provided under the heading "Language of Instruction."
- 4: The education (excluding the preparatory class) will take place at the Tuz Gölü Campus.
- 5: The language of instruction for students enrolled in this program is English, and there is only an English preparatory class. Candidates wishing to apply for this program should carefully read the information under the "Language of Instruction" section.
- 6: Students enrolled in this program will undergo a mandatory one-year Arabic Preparatory Program and a mandatory one-year Turkish Preparatory Program. Candidates wishing to apply for this program should carefully read the information under the "Language of Instruction" section.
- 7: Students enrolling in this program are required to wear the uniform necessary for the profession during practical courses.
- 8: During application process, a health report will be required due to the nature of profession. Candidates choosing this field must meet following conditions in order to be eligible to practice the profession:
  - 1) The candidate must not have a criminal record or an archive record in the criminal registry.
  - 2) For women, the height should be between 160 cm and 180 cm, and the weight should be no more than 5 kilograms above or 15 kilograms below the last two digits of the height in centimeters.
  - 3) For men, the height should be between 170 cm and 190 cm, and the weight should be no more than 5 kilograms above or 15 kilograms below the last two digits of the height in centimeters.
  - 4) The health condition must be suitable for flying (Candidates must obtain a report from a health institution authorized by the Directorate General of Civil Aviation, confirming that their health is fit for flying).
  - 5) When wearing the cabin crew uniform, there should be no visible tattoos, scars, or similar marks on the body.
  - 6) The health report must be obtained from the healthcare institutions listed in the link: "[http://web.shgm.gov.tr/documents/sivilhavacilik/files/pdf/saglik\\_birimi/yetkili\\_saglik\\_kuruluslari.pdf](http://web.shgm.gov.tr/documents/sivilhavacilik/files/pdf/saglik_birimi/yetkili_saglik_kuruluslari.pdf)".
- 9: Candidates who choose this field are required to obtain a Health Report from a Turkish Republic health institution, certifying that they do not have "Color Blindness," which would prevent them from performing profession and/or duties assigned in profession.
- 10: Applicants for the program will be selected through a special aptitude test. Candidates who choose this field are required to obtain a report from a Turkish Republic health institution confirming that there is no obstacle to their education in applied sports departments at universities.
- 11: Candidates applying for this field must not have turned 35 years old by the start date of the aptitude test.
- 12: This applies only to students with TRNC nationality, within the framework of the Cooperation Protocol signed between the Ministry of National Education of TRNC and T.C. AYBU on July 13, 2023.
- 13: For candidates applying to the Medicine and Dentistry programs based solely on their diploma grades, a minimum success rate of 90% is required. Students admitted to the Medicine (English) program must present a C1 level Turkish language certificate in order to start their 4th year. Candidates wishing to apply to this program should carefully read the information under the "Language of Instruction" section.

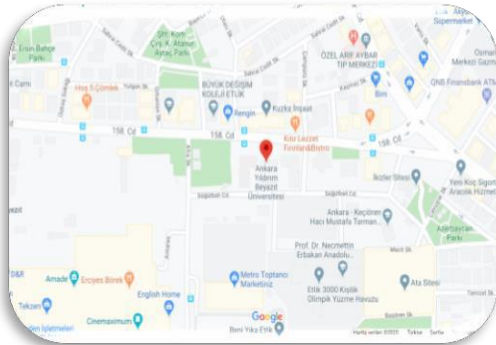

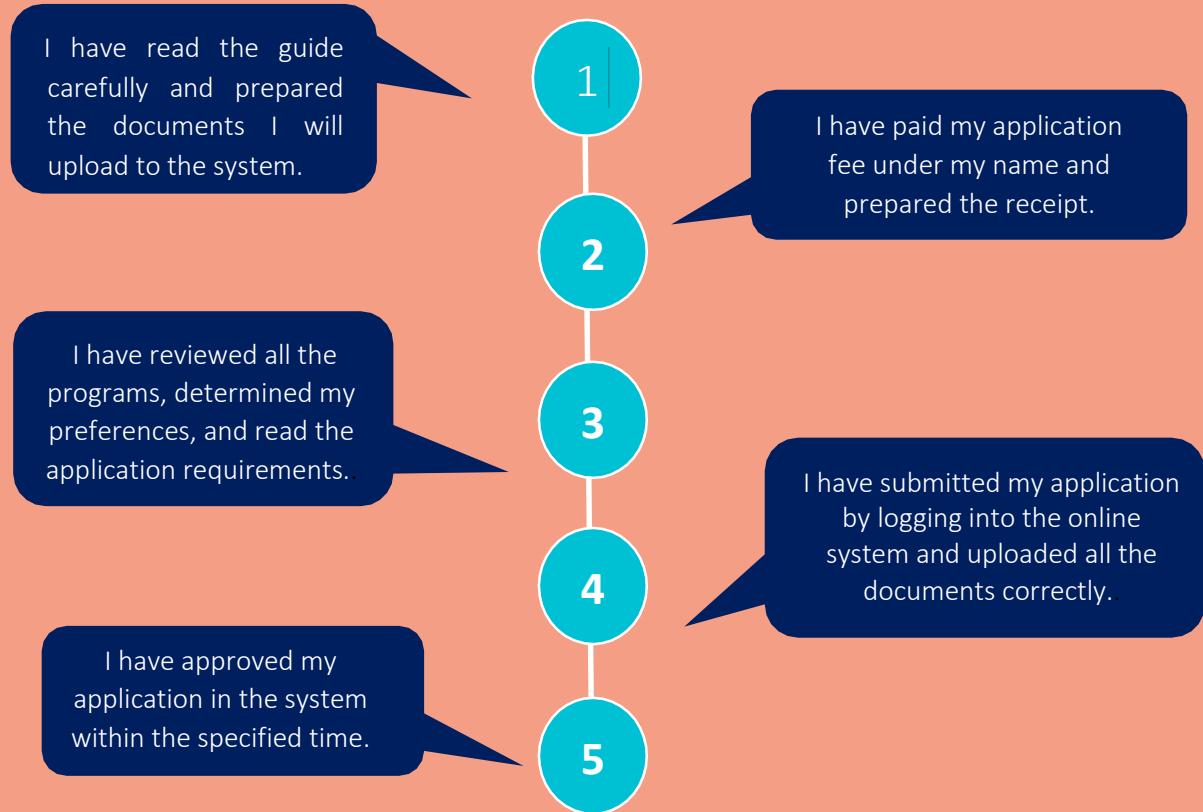
